Supplementary information to price list

- In accordance with Internal Regulation of Comenius University No 9/2017 Directive of the rector of Comenius University as stated in the Amendment UK no.4/2020 laying down rules for determining the price of accommodation in accommodation facilities of Comenius University, this price list applies to long-term temporary accommodation in the months September to June for:
 - full-time students in faculties of CU,
 - full-time students of public or state higher education institutions with which CU has concluded an agreement on the provision of accommodation services for the relevant academic year,
 - full-time students of other public or state higher education institutions,
 - government scholarship holders.
- The price list also applies to temporary accommodation during the months of July and August for
 - full-time doctoral students in faculties of CU,
 - students in faculties of CU whose study programme includes an internship during these months,
 - students in faculties of CU who have been awarded a social grant for these months.

If students of faculties of CU under (b) have an internship lasting less than 4 weeks, the price of accommodation is adjusted (reduced) in proportion to the duration of experience in weeks.

- The accommodation prices quoted in this price list are quoted without value added tax except for the prices quoted for July and August, where the accommodation price includes value added tax at 20% (not applicable for cases under (2)).
